



DOCUMENTS NEEDED FOR LEGAL CLINICS

PLEASE NOTE: everyone requesting assistance at legal clinics must have a valid driver's license or state-issued id in order to participate in the legal clinic & have necessary documents notarized.

Expungement (Felony or Misdemeanor):

- Record(s) of any previous expungement
- A copy of your sentencing order and copies of any and all documents related to the incident you want to be expunged
- Proof that terms of sentence have been completed/complied with – obtain abstract from court to show that you have completed the terms. Can also obtain certificate showing that you have completed terms of probation
- Copy of your driver's license or state-issued ID

***Custody:**

- Child(ren)'s birth certificate(s)
- Divorce judgment
- Child support/visitation/custody/guardianship orders
- Any documents supporting need for change in custody
- DNA testing relating to child(ren)
- Copy of your driver's license or state-issued ID

***Emancipation:**

- Copy of birth certificate of person who wants to be emancipated
- Copy of documents supporting need for housing and/or job
- Child support order (minor's or minor's child(ren)'s); minor's child(ren)'s birth certificate(s)
- Your high school diploma (if applicable)
- Your college transcripts (if applicable)
- Copy of your driver's license or state-issued ID

***Guardianship**

- Child(ren)'s birth certificate(s)
- Existing child support/visitation/custody/guardianship orders
- DNA testing relating to child(ren)
- Copy of your driver's license or state-issued ID

***Irreconcilable Differences Divorce:**

- Proof of joint property or debt
- Any child support/visitation/custody/guardianship orders in place
- Paternity results should wife have a child born during the marriage who does not belong to her husband
- Marriage license (not required, but you do need to know the month, year, county, and state of marriage and separation)
- Copy of child(ren)'s birth certificate(s)
- Copy of your driver's license or state-issued ID
- Rule 8.05 Financial Statements



DOCUMENTS NEEDED FOR LEGAL CLINICS

***Name Change:**

- Copy of birth certificate of person who needs the name change
- Correct spelling of name to be changed from and to
- Any supporting documents which may reflect client's proposed new name
- Correspondence from the Mississippi Department of Health
- Copy of client's driver's license or state-issued ID

***Simple Will/Power of Attorneys/Advance Healthcare Directives**

- List of property to be distributed in will and prospective beneficiaries
- Contact information for beneficiaries/agent
- Copy of testator's (person having will drafted) driver's license or state issued ID

***Visitation**

- Stipulated Agreement of Support and Admission of Paternity, if applicable
- Order approving Stipulated Agreement
- Order for Withholding
- Copy of petitioner's driver's license or state issued ID
